| Entrance Fee*: | £2,500 (except Foundationers) with £1,250 credited after the completion of the first term. |
| Additional Deposit*: | One term's fees in advance (Payable in addition to the Entrance Fee by parents of pupils whose normal residence is outside the United Kingdom). |
| Family Discount: (on termly fee only) | 5% discount on net termly fees for a third child at Rugby or Bilton Grange. 7.5% discount on net fees for fourth (and subsequent) child at Rugby or Bilton Grange. |
| Co-curricular Charges: | Please see the separate booklet produced detailing charges for additional paid for activities such as music tuition, LAMDA lessons, dance tuition and sports coaching. Please note that these fees will have VAT applied for Lent 2025 onwards. |
| Optional Insurances: | The below insurances are available on demand. Please see the School Portal for details. Personal Effects: £7.70 per term (total sum insured £5,000 p.a., limit £2,000 per article, £25 excess). Fees Refund: 0.58% of the termly fee for boarding students and 0.75% of the termly fee for day students. Private Healthcare: £150 per term (AXA PPP is the provider). Personal Accident: This incorporates emergency dental care and is Included in fees. |
| Rugbeian Society Subs: | Lifetime membership of the Rugbeian Society is charged based on the number of terms the student plans to attend and new students joining the School in 24-25 will pay £811 in total over their time at the School. |
| Terms and Conditions: | Please see the School's Terms and Conditions on the parental portal for further information about the payment of fees and extras. Copies are available on request from the Bursary. Please note in particular that a full term's fees are due if a student is withdrawn without a full term's notice, in writing, to the Head Master. |
| VAT: | Our fees for 2024/25 were set at the above, pre-VAT rates for the year. The Government Budget on 30 th October 2024 confirmed that they would apply VAT to independent school fees from 1 st January 2025. Rugby School is applying a 6.75% reduction to VATable fees in support of parents which leaves the gross fees payable (after VAT) as above. |
| Annual Fees: | The annual fees for the school are divided equally between the three terms as above, although these have been adjusted in 2024/25 to account for the introduction of VAT. |
| Composition of Fees (fees in advance Scheme): | If you would like to pay fees in advance, please contact the Finance Department (see below) who would be glad to help you use the School's Composition of Fees scheme. Any payment of fees by way of the Scheme on or after 29 July 2024 will be against fees including VAT. There can be no guarantee that prior payments will not have VAT added in due course. |
